The following criteria will be used to evaluate your performance in the oral debate. In general, I will provide a single grade to each team. The exception to this will be when there are wide discrepancies between team members in terms of their apparent level of preparation and mastery of the topic under debate. It is to your advantage to have rehearsed your main statements to be certain you are able to present smoothly and within the time parameters.
