Academic Subgroup – Reopening Taskforce – Syllabi Masking Policy as of 8/14/21

Masking Policy for syllabi:

In this class, as elsewhere on campus, students must comply with all University health and safety protocols, including:

- The indoor masking mandate announced on August 13, 2021 that requires all vaccinated and unvaccinated students, employees, and visitors to wear masks indoors starting on Saturday, August 14. This requirement applies to:
 - In-person instruction (all indoor classrooms and/or instructional spaces), including this class;
 - In-person indoor events;
 - Any community member traveling between classes within common areas of a University building;
 - o Any community member in common areas within University-owned on-campus housing; and
 - Any community member using the campus shuttles.
- This mandate is designed to limit the transmission of the virus within our community and preserve our ability to offer an in-person teaching and learning experience throughout the fall semester.
- This mandate follows the CDC (Centers for Disease Control) recommendations fully vaccinated individuals living, working, or attending school in counties with **substantial** or **high** transmission rates

- It is also in keeping with the CDC guidance for non-vaccinated individuals that they should continue to wear face coverings that completely cover the nose and mouth for their safety and the safety of others when within 6 (six) feet of other individuals.

 have been vaccinated. Likewise, faculty and staff should not ask students about their vaccination status. Please
 respect the decision of individuals who choose to wear a face covering outdoors and/or in other settings beyond
 what is covered by the current masking mandate.
